The following Terms and Conditions apply to memberships provided by the Women's Business Club.

1. ACCEPTANCE

Please read this document carefully. These Terms and Conditions supersede all previous representations, understandings or agreements.

- 1.1. Any woman business owner can apply to the Women's Business Club for membership.
- 1.2. The Women's Business Club reserves the right to deny or cancel membership, access to its events or online facilities should the member or their company be deemed unsuitable for membership. No explanation needs to be given.
- 1.3. It is not necessary for Clients to sign an acceptance of these Terms and Conditions for them to apply. Any payment towards the service constitutes agreement and acceptance of these Terms and Conditions.
- 1.4. Membership of the Women's Business Club is conditional to the acceptance of these Terms and Conditions.
- 1.5. Our Terms and Conditions are subject to change without notice.
- 1.6. As a member of the Women's Business Club you will undertake not to set up a similar women's business networking and training organisation from the 'know how' gained by attending the Women's Business Club lunches, to compete with the Women's Business Club.

2. CHARGES AND PAYMENT

- 2.1. Unless Women's Business Club agrees otherwise, the Client agrees to pay:

£497 for a Bronze membership, £897 for a Silver membership

£1997 for a Gold membership

- 2.2. Membership includes the Business Lunch but not the Mastermind Boardroom that needs to be paid separately at £125 per month.



2.3. Membership period is one year from the date of first payment and where paid in monthly installments the member is liable for the full year's membership fee.

2.4. Any woman business owner or its representatives acting in a manner not conducive to the vision and culture of the Women's Business Club can have her membership suspended or withdrawn . Activities that can lead to said suspension or membership cancellation include:

- Gossip of any form within the club or about a member.
- Lack of attendance at meetings.
- Inappropriate or unprofessional behaviour.
- Spamming members via email.
- Inappropriate online content.
- Aggressive promotion through our social media groups.

In such circumstances, no refund of fees will be made.

3. SERVICES

3.1. Members pay an annual subscription fee in return for the following benefits:

- Secured position within the member's profession thereby locking out competitors.
- A listing in the online business directory.

3.2. The member's profession exclusivity is to represent their main business or a one clear part of their business activities.

3.3. Should a business provide more than one main product or service the member may only promote the business activity within the category that they chose when joining the club.

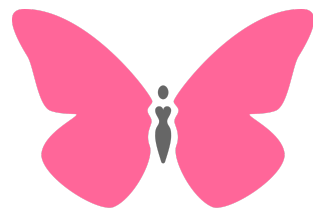
6. GOVERNING LAW
